

ICCA-OPCW enhanced cooperation agreement approved by ICCA Board and Conference of States Parties to the CWC

- ■Leverage Responsible Care® in other regions
- Engage industry support for CWC implementation incl. Art XI
- Established two new bodies:
- Chemical Industry Coordinating Group (CICG)
- Joint Steering Committee (JSC)

"Pre-CWC" I

- Since the mid '70s, formation of working groups "Against Chemical Weapons" in National Associations
- Government-Industry Conference in Canberra 1989
- During negotiations in Geneva offered unlimited access to all of its plants ("anytime, anywhere, no right of refusal").
 Initially Art. IX, then => DOC regime
- Participation of experts in Geneva negotiations
- During PrepCom auditing of data security

"Pre-CWC" II

- publications in trade journals to increase awareness for CW issues
- regular meetings of chemical industry representatives with National Authorities on practical issues of implementation
- support of Australia group activities
- repeated statements that the chemical industry is categorically opposed to the misuse of chemical products for CW production purposes

"Pre-CWC" III

- voluntary measures to prevent misuse of chemicals:
 - distribution of "warning lists"
 - training of sales and customer service functions to identify suspicious inquiries
- information exchange with law enforcement bodies
- several associations have issued handbooks on regulations with regular electronic updates
- joint government-industry exercises on-site
 - inspector training
 - table-top exercise on Sch. 2 facility agreement

"Post-CWC" I

- Informing member companies about their future responsibilities with i.a. publications and training sessions
- Regular meetings with National Authorities (NAs) for a smooth implementation
- Site visits for NAs to familiarize them with the operations of chemical facilities and vice versa
- Setting up organizational structures within companies to manage the declaration and inspection provisions

"Post-CWC" II

- Increased participation in OPCW activities
 - Conferences of States Parties
 - Review Conferences
 - Scientific Advisory Board
 - Advisory Board on Education and Outreach
 - National Authority meetings
 - Chemical Industry / National Authorities meetings
 - Industry Cluster
 - The Hague Award
- Increased involvement in Art. XI activities (see below)







Art. XI activities focus on implementation

of Nr. 2 (a) and (b).

For chemical industry, these are only voluntary measures, however strongly supported by the Responsible Care® Initiative.



OPCW Workshop on Developing Indicative Guidelines for Transport of Hazardous Chemicals by Road Workshop conducted by the Technical Secretariat and the University of Wuppertal

Aim to develop recommendations for the safe transport of hazardous chemicals by road

Three-day kick-off event in April 2022 with participants from Germany, USA, United Kingdom, Britain, Mexico, Kenya, the Philippines and Sri Lanka

Follow-up meeting in Kuala Lumpur, Malaysia, February 2023

Next meeting in November 2023

The recommendations should be officially adopted in 2024 with input from States Parties





Conclusion I (Partnership)

The private sector is not only an important stakeholder and partner in implementation, but can be a resource, i.a. to:

- Share best practices
- Provide expertise about products, services, know-how and complex supply chains
- Use associations and networks to disseminate relevant information
- Strengthen consultation mechanisms between governments and industry







Conclusion II (Dialogue)

- Strengthen consultation mechanisms between governments and industry
- Participate in conferences, seminars etc.
- Work with industry regarding issues for industry
- "Sharing is Caring" governmental authorities and industrial players can form a trustful partnership
